March 24 Registration Form Deadline
All refund, transfer, and cancellation
requests cannot be completed online,
and must be submitted to the ODA via
email to odc@oregondental.org or written
letter received by March 24, 2022. A
\$25 handling fee will be charged for all
tuition refunds. Registration transfers will
be accepted for the same year without
penalty. Refund requests will not be
granted for any reason after 11:59 pm on
March 24, 2022.
